

Dear Representative/Senator _____,

My name is _____, and I am reaching out to ask for your immediate help in responding to the major federal cuts to specialized programs that support survivors of domestic and sexual violence and their children. We have been fortunate to receive the first half of the funds through Oregon's POP 327, but without approval of the rest of the budget (\$5M for ODSVS) and of HB 3196 (\$18.5M), agencies will have to cut their services in half. These devastating cuts mean less access to shelters, crisis hotlines, hospital response, housing support, confidential advocacy, and support groups.
